# **HOW IT WORKS**

### DETERMINE YOUR DOLLAR AMOUNT

The maximum amount you may contribute is the same as your state tax liability or the amount set by the state for your current tax year, whichever is less.

2021 Maximum Allowed Credits:

**\$2,435 for Married Filing Jointly** ORIGINAL: \$1,221 // SWITCHER: \$1,214

**\$1,219 for Single/Married Filing Separately** ORIGINAL: \$611 // SWITCHER: \$608

#### DECIDE IF YOU'D LIKE TO RECOMMEND A SPECIFIC SCHOOL OR STUDENT

Although Arizona law prevents school tuition organizations from using recommendations as the only consideration when awarding scholarships, APESF does use them as one of our primary considerations.
